RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT BY SIGNING THIS DOCUMENT YOU WILL WAVE CERTAIN LEGAL RIGHTS. PLEASE READ CAREFULLY!

Description of events(s) covered, herein collectively called the "TRACK": All events sanctioned by and/or promoted by Eastbound Park.

In full or partial consideration for allowing me to participate in, all related events and activities of the TRACK, I hereby warrant and agree that:

- 1. I am familiar with and accept that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
- 2. 1 have satisfied myself and believe that I am physically, emotionally and mentally able to participate in this TRACK, and that my protective clothing, gear and equipment is fit and appropriate for my role as a participant in the TRACK; and
- 3. I understand that all applicable rules for participation must be followed including the 2019 Eastbound Oval Track General Rules and Regulations, regardless of my role and that at all times during the TRACK the sole responsibility for my personal safety remains with me; and
- 4. I acknowledge I have received a copy of the 2019 Eastbound Tech Rules and the Eastbound General Rules and Regulations 2019 and agree to be bound by them. I understand and accept that I am solely responsible for ensuring that I full comply with the Rules and Procedures; and
- 5. I will immediately remove myself from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration m my physical, emotional or mental fitness, or that of protective clothing, gear or equipment, for continued safe participation in the TRACK.

I UNDERSTAND AND AGREE, ON BEHALF OF MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

- 1. AN UNQUALIFIED ASSUMPTION BY ME OF ALL RISKS associated with my participation in the TRACK even if arising from the negligence or gross negligence, including any compounding or aggravation of injuries caused by negligent rescue operations or procedures, of the Releases, as that term is defined below, and any persons associated therewith or otherwise participating in the TRACK in any capacity, and
- 2. A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have, or may in the future have, against any person(s), entities organizations(s) associated in any way with the TRACK including the track owners and lessees, promoters, sanctioning bodies, racing associations, or any subdivision thereof, track operators, sponsors, advertisers, car owners and other participants, rescue personnel, event inspectors, underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation and loss control activities, regarding the TRACK or event premises, or anyone or more of them and their respective directors, officers, employees, guides, contractors, agents and representatives (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my use of or my presence at event facilities or my participation in any part of, or my presence many capacity at, the TRACK, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE RELEVANT CCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES.
- 3. AN AGREEMENT NOT TO SUE THE RELEASEES for any loss, injury, costs or damages of any form or type, howsoever caused or arising, and either directly or indirectly from my participation in any aspect(s) of the TRACK, and
- 4. AN AGREEMENT TO INDEMNIFY, and to SAVE and HOLD HARMLESS the RELEASEES, and each of them, from any litigation expense, legal fees, liability damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or anyone of them by me or on my behalf, or that of my estate, whether the claim is based on the negligence or the gross negligence of the Releasees or otherwise as stated above.
- 5. AN AGREEMENT that this document be governed by the laws, and in the courts, of the Province in which the TRACK event(s) occurs.
